Relaxations and Concessions:

- For PwD category Candidates, age is relaxable by 10 years for General and 13 years for OBC (Non Creamy Layer) Candidates and 15 years for SC/ST Candidates, as per rules. Persons suffering from not less than 40% of the relevant disability shall only be eligible for the benefit for PwD.
- 2. The age concession to the PwD shall be admissible irrespective of the fact whether the post is reserved for person with disabilities or not, provided the post is Identified suitable for the relevant category of disability.
- 3.
